The undersigned parent and/or legal guardian of (Minor's Name) \_\_\_\_\_ minor, in consideration for the aforesaid furnishing of such direction, services, time, skill, aircraft and other related costs and expenses do hereby forever release and discharge the said pilot, copilot, aircraft owner(s) and/or lessor(s) (as applicable), Angel Flight, Inc., together with its officers, directors, agents, employees, heirs, assigns, and successors in interest of any of the foregoing from any and all claims, demands, liability (under federal law or the law of any state or country), fees, expenses and costs of any kind whatsoever which they as the parent or legal guardian of said minor or which the said minor will have or will claim to have or way have on account of, or in any way related to, directly or indirectly arising or alleged to have arisen from such proposed flight involving the transportation of said minor, parent and/or legal guardian medical attendant and/or the transportation of organs (including blood or any bodily tissues or fluids) in connection with said minor.

Said covenant and release is intended to cover all injuries and conditions of health of said minor which may or may not be immediately apparent following the flight, or which may at any time thereafter develop from injuries, mental or physical, received or claimed to have been received at said time of such flight or in connection with such flight including the cancellation or delay of such flight and the failure to provide a return flight.

In consideration for such flight services furnished by the pilot and/or copilot and other services furnished by the aforementioned parties, the parent and/or legal guardian does hereby covenant and agree to protect and save harmless and fully indemnify the said pilot, copilot, aircraft owner(s) and/or lessor(s) (as applicable), Angel Flight, Inc., together with their officers, directors, agents, employees, heirs, assigns and successors in interest of any of the foregoing from any and all liability (including any claims asserted by or on behalf of said minor) in connection with the proposed flight including the cancellation or delay of such flight and the failure to provide a return flight.

It is understood by the parent and/or legal guardian in executing said release that said parent and/or legal guardian regards the consideration in the form of services, aircraft etc, being furnished by the pilot, copilot, Angel Flight, Inc., or other Agencies is in the form of personalized air transportation of said minor and constitutes significant material and valuable consideration (to both the minor and the legal guardian on the discharge of the latter's legal duty to care for such minor's health) being offered in exchange for this release and further, that such parent and/or legal guardian regards such transportation as a significant and material factor in the well-being and physical prosperity of said minor.
